Capitol Volkssport Holiday Walk on Saturday, December 11, 2021

The 10K walk is actually two 5K loop walks. They both begin and loop back to the Harbor House, where you can take a break and enjoy coffee and cookies before you walk the second loop. One of the walks goes through some of the Eastside neighborhoods and the Olympia Farmers Market. The other walk goes through the capitol campus and along the waterfront. Be sure to stop and view the holiday tree at the capitol.

Rain or shine (and we're hoping for "shine"), we hope to see you and a few of your friends at our holiday walk. An event such as this is an easy way to introduce others to volkswalking.

Proposed Bylaw Change

Article III - Term of Office

Section 3 as it now reads

In case the President is unable to fulfill their term of office, the Vice President will succeed to the office.

Section 4 as it now reads

A special election will be held to fill the vacancy of any other elected office.

Proposed Change

Combine sections 3 and 4 to read;

In case a member of the Executive Board is unable to fulfill their term of office, a special election will be held to fill the vacancy.

Article IV - Duties of Officers

Section 2 now reads:

Shall assist the President, in his/her absence, and perform the duties of that office; serve as a member of the Executive Board. Shall register all year round events (YRE) and publish related brochures. Shall serve as advisor to event Trailmaster and Coordinators.

Proposed Change

Section 2:

Shall assist the President, in his/her absence, and perform the duties of that office; serve as member of the Executive Board. Shall register all events, Year Round (YRE), Seasonal, Traditional and Traveling Guided Walks. Shall serve as backup to event Trailmaster and Coordinator.

Article VII – Membership

Section 2 now reads

Membership year shall run from July through June. Any member who has not paid the annual renewal fee by the end of October will be dropped from the membership roster effective November 1.

Proposed Change

Section 2:

Membership year shall run from July through June. Any member who has not paid the annual renewal fee by the end of September will be dropped from the membership roster effective October 1.

Proposed Standing Rules Changes

Standing Rule 01-1 Expense Reimbursement to Club Membership

Paragraph 3 as it now reads

Expense report must be submitted within 60 days from the time the expense was incurred. An exception is expenses in May and June, which must be submitted by July 3 in order to complete fiscal year end reports. Blank forms are available from the treasurer or secretary.

Proposed Change Paragraph 3

Expense reports must be submitted within 60 days from the time the expense was incurred. An exception is expenses in November and December, which must be submitted by January 3rd in order to complete year end reports. Blank forms are available on the club website or from the treasurer.

Paragraph 4 as it now reads

The treasurer at his/her discretion can approve and pay expense reports totaling up to \$50 before review by the Board. Expense reports above \$50 will be reviewed and approved by the board before payment.

Proposed Change to Paragraph 4

The treasurer at his/her discretion can approve and pay expense reports totaling up to \$75 before review by the Executive Board. Expense reports above \$75 will be reviewed and approved by the board before payment.

Standing Rule 01-2 Commitment of Club Funds

Rule as it now reads

Club members are authorized, without prior approval, to commit the club up to \$50 for supplies or services for club use. Expenditures from \$50-\$150 must be approved by the Executive Board, prior to commitment. Expenditures exceeding \$150 must be reviewed and approved by a quorum of the membership at a general membership meeting, prior to commitment.

Proposed Change to Rule

Club members are authorized, without prior approval, to commit the club up to \$75 for supplies or services for club use. Expenditures from \$75-\$150 must be approved by the Executive Board, prior to commitment. Expenditures exceeding \$150 must be reviewed and approved by a quorum of the membership at a general membership meeting, prior to commitment.

Standing Rule 01-3

Dues for new members as it now reads

Dues for new members will be as follows A. People who join any time between July – December, full year's dues, as in annual dues above B. New members joining between January – June will be ½ of the above dues.

Proposal is to remove this section of Standing Rule 01-3

Standing Rule 02-2 Club Event Planning

Rule as it now reads

Both individual events and YRE's conducted by the club will be planned and carried out using the American Volkssport Association "Event Handbook". The club vice president will furnish the event coordinator the current edition of the Event Handbook to use in planning the event. The vice president will serve as advisor to event trailmasters and coordinators. The handbook will be returned to the vice president following the event.

Proposed Change to Rule

Both individual events and YRE's conducted by the club will be planned and carried out using the American Vokssport Association "Event Handbook". The club vice president will furnish the event coordinator the current edition of the Event Handbook to use in planning the event. The vice president will serve as backup to event trailmasters and coordinators. The handbook will be returned to the vice president following the event.

Standing Rule 03-1 Responsibility of Year Round Event (Site) Tenders

Rule as it now reads

Standing Rule 03-1 Responsibility of Year Round Event (YRE) Site Tenders
Site tender shall maintain one or more YRE sites. The boxes shall have registration sheets, walk
directions, stamp, inkpad, pens, money envelopes, and walk information. Each walk shall have general
instructions for walkers to follow along with a contact phone number. ESVA and club YRE brochures
should also be included.

Proposed change to rule

Standing Rule 03-1 Responsibility of Year Round Event (YRE) Box Tenders
Box tender shall maintain one or more YRE sites. The boxes shall have registration sheets, walk
directions, stamp, inkpad, pens, envelopes, and walk information. Each walk shall have general
instructions for walkers to follow along with a contact phone number. ESVA and club brochures or
business cards should also be included.

Standing Rule 03-3 Site Tender Monthly Activity Report

Rule as it now reads

Standing Rule 03-3 Site Tender Monthly Activity Report

YRE <u>site</u> tenders will complete a YRE Monthly Participation Report each month for each YRE for which they have responsibility. The cut off date for the report is the last day of the month. The completed report and YRE money must be submitted to the treasurer no later than the regular monthly club meeting for the succeeding month. The treasurer, after obtaining financial data from the Monthly Participation Reports will compile it and report it to the membership.

Proposed Change to Rule
