4. August minutes (from the website) were approved as written.
5. The Treasurer's report, emailed to the membership on September 9, was approved as presented.
6. Jim Younkings presented slides from a previous trip to Crazy Horse, which is done as a biannual event.
7. Diane Malone created a booth at the Panorama Health Fair, even though the club declined to participate this year, as she is a resident of Panorama and wished to do so. We may gain some participants as a result of the endeavor, so thank you to Diane.
8. The Salmon Walk will be held this year on Saturday, Oct. 5. Barb Malone is managing the event, and will reach out to the club for volunteers to assist. There will be a \$4 fee for the walk this year.
9. Bonnie Tucker presented info for the AVA Walkfest and Regional Conference, to be held in Silverdale, and around Kitsap Peninsula. Dates are Sept. 19-22, with walks available through the 24th if registration is completed in Silverdale by Sept. 22. More info has been sent by email to the membership, and is also available on the ESVA Website, in Pathfinder, and on Meetup.
 - 9B-Bonnie also gave a recap from the August Back to the Beach trip which collected \$419, and for which the Seabrook Walk proved the most popular.
 - 9C-Karen Younkings announced that the club will take over both Dupont walks which were previously administered by the Over the Hill Gang club, which is disbanding shortly. Mary Clem will be the box tender for the walks, the box will remain at the store connected to the Union 76 station as always, and will remain a YRE, with an online start box option as well.
 - 9D-The Port Gamble walk will be transferred to the Four Plus Fool Hardy Club, to be redeveloped and classified as a YRE.
 - 9E-A discussion ensued about which walks have been discontinued from next year. Mary Clem read from a list taken down at the box tender meeting held earlier in the Summer. She will send the minutes from that meeting to Peter to post on the website.

Karen Younkings stated that a vote will be taken at the next meeting, in October, to decide if the Club will keep the present fee schedule or if they will opt to raise the fees, as some other clubs have done. It is expected that the Treasurer will be able to answer more detailed questions about the funds

present in the account, the rate of discharge, and the difference to the bottom line from various scenarios.
