3. Please also note the sign-up for help with the Holiday Walk on Saturday, December 14.

4. The meeting minutes for October were approved as published on the CVC Website.

5. The Treasurer's Report, emailed to the membership on November 8, was approved as presented. The Treasurer clarified one entry, and also reported that she has, thus far, sold 64 Troll Challenge books.

6. There was a slide presentation of Chase and Pam Greig-Davis' cruise across the Pacific, to Japan.

7. The Club presented a check for \$150 to Perki and Peter Sweet for the Olympia-Lacey Church of God as a thank you to the Church for allowing us to hold our meetings in their Family room. Special thanks to Perki and Peter for arranging for the room, and for setting it up each month.

8. Please turn in your books for the Flag Challenge to Pam by December 31. A call was put out to the Club for ideas for a new Challenge for next year.

9. A reminder was given for the Christmas Party on December 12, as well as a call for donations of snacks to Garfield Elementary School. There is a list of snacks requested on the Party invitation. Bonnie Tucker is once again collecting the donations at (or before) the Party.

Nancy Wittenberg mentioned that the Holiday Walk will have a start time of 10A-12P, and that a permit for entry into the Capitol building was obtained for walkers, the number of which will be printed on the walk directions. 16. The new challenges for next year were discussed.
